## **PROPOSITION**

Shall the Board of Education undertake a project consisting of reconstruction, renovation, and construction of improvements and upgrades to the High School, Middle School, Elementary School and Transportation Center, including, but not limited to, interior and exterior renovations and improvements, mechanical upgrades, High School track improvements, site improvements and drainage, pavement and sidewalk improvements, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work at a total estimated cost not to exceed \$5,250,000 and obtain the necessary funds by using up to \$950,0000 from the Capital Reserve and, for the balance, the levy of a tax in the amount of \$4,300,000 upon the taxable property of the District to be collected in annual installments in the years and in the amounts as the Board of Education shall determine and in anticipation of such tax bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$4,300,000, and a tax is hereby voted to pay the interest on said obligations when due.
