## **PROPOSITION**

Shall the Board of Education undertake a project consisting of reconstruction, renovation, and construction of improvements and upgrades to the High School, Middle School, and Elementary School, including, but not limited to, interior and exterior renovations and improvements, mechanical upgrades, HVAC upgrades, site improvements, original furnishings, fixtures and equipment, architectural fees, and all other costs incidental to such work, at a total estimated cost not to exceed \$26,900,000 and obtain the necessary funds by using up to \$4,050,000 from the 2022 Capital Reserve Fund and, for the balance, the levy of a tax in the amount of \$22,850,000 upon the taxable property of the District to be collected in annual installments in the years and in the amounts as the Board of Education shall determine and in anticipation of such tax bonds and notes of the District are hereby authorized to be issued at one time, or from time to time, in the principal amount not to exceed \$22,850,000, and a tax is hereby voted to pay the interest on said obligations when due.

**NOTICE IS GIVEN** that voting upon the foregoing Proposition will be by paper ballot and will take place on December 9, 2025 in the Solvay High School Aux Gym, 600 Gertrude Ave, Solvay, New York 13209 from 12:00 noon to 9:00 P.M. prevailing time.
